

Description	lgD, a member of the immunoglobulin (lg) family, is expressed in naïve B cells. It has 3 lg-like domains and exists in a transmembrane and a soluble form. In general, lgD is not secreted and usually its expression is lost after the lg isotype switch. After antigen binding, lgD signals through the CD79a/CD79b (lg $\alpha$ /lg $\beta$ ) heterodimer, resulting in the activation of the B cell.
